## Parental Involvement Policy

### **PART I. GENERAL EXPECTATIONS**

Douglass ECLC agrees to implement the following statutory requirements:

  - Mailing letters home to parents when this has occurred
  
5. Douglass ECLC will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
  - the state's academic content standards,
  - the state's student academic achievement standards,
  - the state and local academic assessments including alternate assessments,
  - the requirements of Part A,
  - how to monitor their child's progress, and
  - how to work with educators.
