

# Lamar Primary Parental Involvement Policy

## **PART I. GENERAL EXPECTATIONS**

Lamar Primary agrees to implement the following statutory requirements:

1. Lamar Primary will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:

The school will respond to any such suggestions as soon as practicably possible by:
  - Returning phone calls and emails by parents to schedule a time for a meeting and then following up with said meeting between teacher and parent (and/or administrator)
  
5. Lamar Primary will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
  - Mailing letters home to parents when this has occurred
  
6. Lamar Primary will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
  - the state's academic content standards,
  - the state's student academic achievement standards,
  - the state and local academic assessments including alternate assessments,
  - the requirements of Part A,
  - how to monitor their child's progress, and
  - how to work with educators.
